My wife & I attended the 1988 gymnastics and booked and paid for a double room at the OMNI Intl. and two tickets for the Saturday concert. We booked in mid June and need a receipt. When we reached the OMNI Sat evening Sept 3<sup>rd</sup> we discovered, as several others did, that there "was no room at the inn". After quite a lot of discussion we eventually were provided a room at the Baltimore next door. We had to pay for this room \$80<sup>00</sup>. By this time all hope of attending the concert had faded. On Sunday we moved out of the Baltimore back to the OMNI but had to pay again for Sunday night - receipt enclosed. When I took this matter up with the registration table on Sunday morning your member took my original receipt for the two nights, stapled our concert tickets to it and said that we would be reimbursed in full plus a sum of approx. \$18<sup>00</sup> - I don't quite remember - for money which I had overpaid. Four weeks has gone by and have not heard from you. This is a gentle reminder.

About two weeks ago I wrote to Box N° 21545 in Baltimore, as it was the only Postal address given for the Baltimore '88 W.N.C.A. I sent a copy of the letter to yourself as Secretary of the Welsh National G.G. Assoc. Inc. in case the postal box was only for the duration of the '88 festival. The letter was in regard to money owing to myself for a room, booked for two nights at the Omni plus tax (\$177<sup>60</sup>) and two tickets for the concert \$40<sup>00</sup> (less 2 registrations) = \$30<sup>00</sup>. The room was not available upon arrival and we had to stay at the Baltimore Hotel but had a room at the Omni on Sun but had to pay for both nights again. We were assured at the registration desk on Sunday morning that we would receive a full refund for the \$177<sup>60</sup> and the two concert tickets \$30<sup>00</sup> which were not used owing to the mixup or messup. Call it what you will. I agree with the report in the Nennau that the organization left a lot to be desired and I might add that we were not alone in having booked rooms that were not available upon arrival. It is now 7 weeks and we have not heard a word. Can you advise me at your earliest convenience what is being done to resolve this matter as it is actually a Welsh National G.G. Assoc. Inc. function which was mismanaged by your Baltimore representative.

I leave it to your personal good judgement whether you publish this letter in the Minnan or forward it to M<sup>s</sup> Morgan - as I do not have her address.

Dear M<sup>s</sup> Morgan. I wrote to you months ago regarding monies owed to myself re. a real messup at the OMMI Hotel Sat Sept 3<sup>rd</sup>. and I have had no reply. To refresh your memory, we booked and paid for a room at the OMMI for Sat & Sun night. After a long hard drive from 8:30 AM to 7:30 PM with one short stop we expected to throw our bags in our room and rush off to the concert for which we had also prepaid. Instead we found that we had no room reserved for us, we had several others in the line-up, and we consequently missed the concert entirely. We had a room at the Baltimore Sat night, for which we had to pay, and moved back to the OMMI on Sunday night, FOR WHICH WE HAD TO PAY AGAIN. We were advised at the registration desk on Sunday morning that we would be getting a full refund of the \$177<sup>00</sup> plus the \$30<sup>00</sup> concert tickets. I sent you all the necessary

receipts to substantiate this. I sent a copy of that letter to the general secretary Nelson M. Llewellyn, Warren Ohio, should your Baltimore BOX # no longer be in existence and I also wrote him again on Oct 17 but his typewriter must be in the same state as yours.

If I do not hear from you in two weeks from this date I will be asking my lawyer to take action.

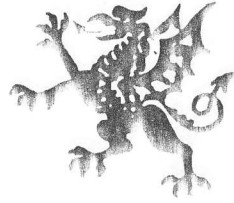

Never, in all the years that I have been attending National Welsh Gymanfa Ganus, have I had such trouble with a hotel or with the registration committee!

Since all the registrations and requests for tickets to the special events went through Travel Destinations Unlimited, on August 7th, I wrote to Pam Eaton, Manager-Group Operations stating that I was acting for S. Marion Droppa, who had been taken seriously ill and would be unable to attend that Gymanfa Ganu and asked that her registration and tickets for all special events be cancelled, and a check to her be sent to me. She was out of town for treatment and I was to handle the matter for her. I heard nothing and when I was at the Gymanfa Ganu, I spoke to you and you assured me that the matter had been turned over to you and that a check was ready to give me, if I would call for it the next day. I asked at the registration desk the next day and was told that the check was not ready and that it would be sent to me within ten days to two weeks. I am still waiting for it and Mrs. Droppa is quite upset that she has not had her money returned. The reason I have taken so long to again write is that I had a bad fall and was unable to get to the matter before this.

I am inclosing another copy of Marion's registration confirmation and also, copies of the checks that were sent. Since the sum of \$77.00 is involved and she is on a very limited income, I think a check should be forthcoming to me in her name as soon as possible. The cancellations were made almost a whole month in advance and I think this matter should have been taken care of, even before the Labor Day weekend. If I do not hear from you within a week, I shall take the matter up with the National Gymanfa Ganu treasurer. I trust that I will not have to do that.

Dear Sir, I am writing to you to ask if you can help me in finding the person I wrote to for refund that three of us made for the National Gymnastia Gymn in Baltimore.

I tore a ligament in my right knee, and I am still laid up. I had another cortisone shot yesterday when I went to see my Doctor. It eases the pain for a while. One of the other ladies, Mrs Marion Rench, had an eye operation the week of the Gymnastia Gymn. The third lady, Mrs Margaret Jones Krauss could not go on her own as she depended on me to make all the arrangements. She is in her 80's.
