LABORATORY FACILITIES.

As there are no laboratory facilities within the District arrangements have been made for the examination of Pathological and Bacteriological specimens at the Cardiff and County Public Health Laboratory, The Parade, Cardiff. A number of samples of water and milk have been sent for analysis during the period under review.

MATERNITY AND CHILD WELFARE.

Monthly Ante-Natal and Child Welfare Clinics are held in the Town Hall in conjunction with the Cowbridge Rural District Council.

DRAINAGE AND SEWERAGE:-

The old town drains discharge into the River Thaw which passes through the centre of the town. The discharge of such a considerable amount of untreated sewage into the river, especially during periods of drought, is a most serious Sanitary Nuisance. Most of the Old Town Drains are of the Box type and it can easily be imagined how the soil for some distance around the drain must be sewage sick.

The more modern portion of the town drain into cess-pools situate in the gardens of the houses concerned.

In conjunction with the villages of Aberthin, Llanblethian in the Cowbridge Rural Area a joint scheme for Sewerage and Disposal of the Borough and these districts is being prepared with a view to a Government Grant under the Rural Water and Sewerage Act, 1934. It is sincerely hoped that this present attempt to modernise the drainage system of the town will meet with success.

RIVERS AND STREAMS.

As stated above the river Thaw passes through the Borough and it is seriously polluted by crude sewage from the Town and other drains.

PUBLIC CLEANING:-

A contract is placed with a local Contractor for a twice weekly removal of house refuse within the area. The disposal site at Three Ashes has been closed and arrangements made with the Cowbridge Rural District Council for the refuse to be disposed of at the latter's disposal site at Llanmihangel, Nr. Cowbridge.

A Sanitary Cart is kept by the Local Authority for the purpose of emptying the contents of the cesspools within the Borough at the owners expense. The contents are disposed of by emptying over agricultural land.

SHOPS.

The Sanitary Inspector holds the appointment of Shops Inspector and periodical inspections are made to ensure that the requirements of the Shops Act, 1934, Public Health Act, 1936 and Section 14 of the Food and Drugs Act, 1938 are carried out.

SMOKE ABATEMENT.

It has not been necessary to take any action for smoke nuisances during the year.

RODENTS.

Numerous inspections and advisory visits were made during 1944. The Old Town drain, with no manholes, provide excellent cover for rats and are almost impossible to treat by the Ministry's methods.

AMBULANCE FACILITIES.

For Infectious Cases:-

The Cowbridge Borough Council is a constituent authority of the Bridgend Joint Hospital Committee and Infectious cases requiring admission to Hospital have the use of the Ambulance provided by the Committee.

For Non-Infectious Cases.

No Ambulance is available within the District for Non-Infectious and Accident Cases. Whenever an Ambulance is required for these cases, arrangements are made with the St. John's Ambulance.

HOSPITALS.

(a) General Hospitals:-

(b) Orthopaedic Hospital:-

The Prince of Wales Hospital, Cardiff has a Convalescent Hospital at Crossways, Cowbridge at which Orthopaedic cases are treated.

(c) Infectious Cases:-

Cases from this area are admitted to the Joint Hospital situate at Cefn Hirgoed, Bridgend.

(d) Maternity Hospitals:-

There are no Maternity Hospitals or Nursing Homes in the area. Cases from this District can be admitted to the Maternity Block of the Bridgend Infirmary. Difficult cases may be removed to Cardiff Royal Infirmary.

SECTION D.

SANITARY CIRCUMSTANCES OF THE AREA.

Water Supply:-

A constant supply of water is available in the Borough from the mains of the Mid-Glamorgan Water Board which pass through the town. The supply is satisfactory as regards purity but the excessive hardness is the cause of much complaint.

98.6 percent of the houses in the Borough are connected to the public mains.

All samples of water for Chemical and Bacteriological purposes during the year proved to be satisfactory.

Swimming Baths and Pools:-

The Council operate a swimming bath constructed on the River Thaw. The pool is periodically emptied and cleansed. During the summer months a caretaker is in attendance at the pool.

Schools:

Two schools (Cowbridge Grammar School and Pontfaen Elementary School) are situated in the Borough.

Grammar School:- Mains water is provided and water closets installed. Showers and baths are also available.

Pontfaen School:- Mains water is provided. Pail closets are available and there are regularly cleansed and the contents buried. It is to be hoped that the Education Authority will give serious consideration to the installation of water closets in the immediate post war years.

MILK SAMPLES:

Samples for Bacteriological Examination.

Samples were taken from purveyors in the Borough during 1944.

The results are, on the whole, very good.

Samples of milk for the presence of Tubercle Bacilli.

The Cardiff and County Public Health Laboratory extended their facilities for the biological testing of samples of milk during the year. This area is allocated six samples in a full year. It is, therefore, possible to have the milk supplied by each retail purveyor examined annually for the presence of Tubercle Bacilli.

Meat and other foods:-

The meat supplied to Butchers in the Borough is obtained from the Ministry of Food's Slaughterhouse at Barry.

Butchery and Grocery Shops are regularly inspected and unsound foodstuffs dealt with according to the Ministry of Food's instructions.
