#### STILL HERE - AND DETERMINED TO WIN!

On Feb. 8th our Picket and Peace Camp enters its' third week. For those still unaware, we are campaigning for an end to work on the nuclear bunker, for non-co-operation with Government plans for Nuclear war and for the re-allocation of funds for essential and peaceful services. What have we acheived?

\*Enormous publicity on TV, radio and newspapers and a great deal of public interest in the issues raised by the bunker. 250 people turned up for a meeting on site on 31 January and 3 County Councillors spoke in support of our protest. Hundreds of others have played a part in keeping the picket going.

\*Practical help, support and goodwill has come from many individuals and organisations too numerous to name all but including women at Greenham, East wales Congregational ministers Conference, George Wright of the Wales TUC, and mardy Lodge of the NUM who thoughtfully provided a brazier and coal to warm our spirits. \*Donations of over £300 - including a generous one from Greenham women - have enabled us to purchase our own Peace Caravan which is now on site and can sleep 4 people. We need every penny if we are to continue the fight.

THE CAMPAIGN AGAINST THE BUNKER IS SPREADING - But we need YOUR Support: Please raise this issue with your M.P., Councillor, Trade Union, Political Party, etc and send a message of protest to the Chairman of Mid Glamorgan County Council, County Hall, Cardiff - we'd also like to hear of your concern

#### LATEST DEVELOPMENT -

Mid Glamorgan Public Protection Committee visited the site on Feb 1st.
Approx 50 Councillors turned up and were lobbied by a similar number of
our supporters. The Chief executive and P.F. Chairman met Peace Camp
representatives and were left in no doubt of our determination. Council
resorted to the pathetic view that the bunker was needed for civil
purposes' which is presumably why they need blast proof doors and walls,
decontamination shower, water re-cycling equipment and a Games Room to
help pass the 14 days or more the officials plan to be in seclusion
according to their own documentation!

After indicating that neither we nor the public are fools our representatives withdrew but were subsequently informed our request for a meeting with the Committee was being brought forward from mid March to February 18 - indicating some response to the pressure now building up on the Council.

#### TRADE UNION SUPPORT

Wr George Wright (Wales TUC) and Mr John Foley (ISTC) have expressed concern about the Bunker issue and we are in touch with trade unions. We hope T&GWU and related unions will now <u>black this site</u> in view of the stated views of the unions and Labour Party Conferences.

#### CHURCHES

A constructive meeting and exchange of views took place on Feb 5 with Bridgend Council of Churches who our considering suggestions for joint co-operation with CMD in the future. Three churches have already pledged support.

"H-BOMB ON OGWR" - Supplementary Research Paper, No. 1

#### County Bunker, Bridgend Industrial Estate

The present capital works at this site - described by the Home Office in 1979 as a "County Wartime Headquarters" - can be traced to the events following the decision by the U.K. and NATO Governments on 12 December 1979 to agree to the deployment of U.S. Cruise missiles.

Following receipt of a Home Office Circular on "Wartime Communications for Local Authorities" the Chief execuitive of mid Glamorgan County Council presented recommendations to a sub-committee of the Public Protection Committee. In a Confidential Report to the sub-committee on 17 march 1980 it was noted that:

"The system is specifically designed to meet the needs of wartime regional government in the immediate post attack period..."

The committee were told that private speech lines existed between the County control and Sub Regional Readquarters and also to police and military headquarters and the U.K. Warning and Monitoring Organisation(who provide data on nuclear fallout and bomb blasts) The facilities at Bridgend had been fully tested in a recent major exercise but further direct lines were needed between County and District Controls at a cost (before grant aid) of £2,000 connection plus £5000 rental p.a.

In his report the Chief executive stated that to bring the Control up to standards including "proper control and feeding arrangements after the attack" would cost in the region of £250,000. The project was in the provisional list of the capital programme. members were asked whether it "is of sufficiently high priority to proceed with it in the next year or two."

#### The Building

Three weeks prior to the sub-committee a report, bloom to to from the end of the referring to a site meeting at waterton, made proposals for a new control room and a "new building linking the two bunkers housing sleeping accommodation", kitchen, messroom, water re-cycling facilities, rest area and a room for "varying numbers of female staff":

"I am of the opinion that 80 people, used for most of their lives to a comfortable standard of living, and who would be shut in these conditions for a period of up to or even exceeding 14 days, would find the situation intolerable with a consequent lowering of morale and performance, and therefore a loss of efficiency of the unit."

To ensure such "comfort" it was recommended that carpets be laid, seperate toilets be installed and a games room be provided, the estimated cost of such works (1980 prices) being put at £215,000, not including furniture, mattresses or bedding.


Doubts about the viability of this project emerged at this stage. The letter to the Chief Fire Officer states finally:

"You may feel that if we were to spend money at this mevel we should consider whether Waterton and the exisitng bunkers are the right location for the Control Centre."

#### Decision Time

By June 1980 a decision in principle to proceed with a major renovation of the Bridgend Bunker had apparently been taken. The Director of Building Works had prepared an estimate and a meeting was being arranged with Home Office advisers "to assist in specifying equipment".

- A Report dated 17 June 1980 contained specific recommendations:
- Decontamination room and shower near main entrance,"
- -"doorways to face away from preatest blast sources"
- -Blast walls and contouring of earth embankments,
- -Water tanks increased from 1,000 to 8,000 gallons and with fuel, to be sited underground.
- -Water to be re-cycled for toilet use "thereby avoiding complete flushing failure if mains service cut off."
- -Security- "all doors, ventilation grills, switchgear, etc to be given special consideration for unauthorised entry and from blast effects."
- -New electric generator since "sas supply is exposed to blast and internal interference."



Valentines Day is the 21st day of our siege of the nuclear bunker. We are here to demonstrate that the powers of love and peace are greater than those of hate and war. Evil triumphs because good men do nothing. We will not allow evil to triumph. We shall overcome, and see the bunker closed or put to constructive purposes.

#### DECISION TIME AT COUNTY HALL

Our 4th week of occupation also marks the most crucial test yet of the Council's Nuclear Free Zone policy and the first major opportunity for work on the bunker to be called off in response to public opinion.

Please speak to your Councillors and try to be present (with banners) on the steps of County Hall, Cardiff at least one hour before these meetings;


- \* Wednesday. 17 February At 11am the controlling Labour Group will meet and probably consider a resolution against the bunker from Cllr Ray Davies (Caerphilly) who also wants the Council to withdraw from Operation Hard Rock. Later, they may decide to take disciplinary action against Councillors, like Cllr Jeff Jones, who are supporting CNDs stand against the bunker project.
  - The Labour Group must be reminded that it is Labour Party policy to comply in a <u>minimal</u> way with the Governments civil defence plans this does not mean building a prestigous £400,000 super-bunker for bureacrats:
- Thursday, 18 February- The full Council will meet at 11am and the bunker issue may be put to the vote. If so a significant number of Labour members may decide to vote against their Leader's recommendation. CND has circulated every councillor with the facts so there are no excuses this time. Much will depend on how much pressure we and the public can bring to bear to make councillors accountable. We know Plaid members, some Labour members and Clir Arthur True (Rhondda) are committed to voting against the bunker. We shall be watching the others very closely one day they will be wanting our votes!
- At 2.30pm our delegation will meet the Public Protection Committee and will put the case against the bunker and for a wholehearted commitment to the policy of Nuclear Free Zones.

  IT IS ESSENTIAL TO GIVE MAXIMUM SUPPORT TO YOUR REPRESENTATIVES BY DEING THERE IN LARGE NUMBERS AND TACKLING COUNCILLORS we know we can count on you. Thank you.

### BOOST FOR PEACE CAMP AIMS

- -Comore M.P. Ray Powell has joined the growing list of influential people and bodies concerned about the bunker. He told the South Wales Echo, 10th Feb: "If the centre was being equipped for nuclear war, in no way could I condone the actions of the county council." He also said he would make the "strongest possible protest about this scandalous waste of money and would investigate the bunker and question the Government.
- The South Wales area of the <u>National Union of mineworkers</u> has given £100 towards our campaign against the bunker and is actively considering ways of supporting the action.
- The 40 strong G.m.C. of the Ogmore Constituency Labour Party yesterday (13 Feb) unanimously called on Labour councils to refuse to allocate funds for the provision and maintenance of wartime control centres and to refuse to participate in nuclear exercises. They also voted to reallocate employees engaged on nuclear war plans to peaceful duties. This resolution is being sent to the annual conference of the Labour Party in Wales later this year.

# VICTORY IN SIGHT!

Nuclear war preparations in Mid Glamorgan are to be halted and the County's declaration of a nuclear free zone is to be made a reality. CND was given these assurances following a meeting with our delegation at County Hall, supported by a very effective lobby.

The following measures are contained in a Statement of Intent placed before the Public Protection Committee:

- 1. Withdrawal from the Government war Emergency Scheme.
- 2. The Bunker to become a Civil Amergency Centre only. (Cllr Squire later said it would be open to inspection and to regular visits by District Councils).
- 3. Instructions to officers to disentangle and divorce the centre from anything which might be regarded as wartime emergency activity.
- 4. Henceforth officers would interpret their statutory duties in a manner consistent with the belief that there is no meaningful defence to nuclear war. The Home Secretary would be informed of this policy.

Future of the Bunker?

Reports from the controlling Labour Group suggest the bunker may be modified by the installation of windows, the removal of decontamination equipment and the dropping of plans to earth over the controversial link building. These are suggestions only which may be the subject of an architects report to the rublic frotection Committee who will consider the Statement of Intent at their meeting on 25 February at 2.0pm.

After 28 days of picketing Victory is now in sight! --

PLEASE, PLEASE MAKE THE FINAL EFFORT AND BE AT COUNTY HALL, CARDIFF ON THURBURY 25th Feb FROm 1. Opm with banners, etc to Lobby Councillors

We still need certain guarantees - Will they permit inspection by us? Will they withdraw from "Operation Hard Rock"? Will they fully support CND's Easter Rally on April 10th? Can we have full and frank information? Why not ask your Councillor - and while you're doing it tell him we don't want Government propaganda films shown to our children in mid Glam!

The Media

Once again our Campaign has caught the headlines in the press, radio and T.V. Speaking on BBC. TV(wales) Paul Llewellyn, Chairman of mid Glamorgan CND said the statement by Cllr Squire, the Leader of the Council was "a vindication of CND's campaign. If these measures were made effective and monitored it will mean an unprecedented victory for CND."

MEANWHILE - THE PEACE CAMP WILL GO AHEAD (Public Meeting Sun 28 Feb at 2pm)
On Tuesday 23 February we hope to celebrate the declaration of a
Nuclear Free Clwyd and therefore a Nuclear Free wales - the first country
in the world to declare itself nuclear free - with the lighting of
a Symbol of Peace from 8.0pm at the Peace Camp/"Bunker" - why not join
us in what we all hope will be a Triple Celebration for Peace - Clwyd,
Mid Glam and All Wales. Bring entertainment and refreshments!

Remember Greenham - they remembered us! On the same day Newbury Council may decide to evict Greenham Peace Camp. Please support the demonstration to prevent this happening or at least protest by writing to the Council.

### WAR WORK HALTED - Major breakthrough for Peace

As we predicted, work on the bunker has virtually ceased by order of the Public Protection Committee, the same Committee which began the work.

Officers have been instructed to arrange for the installation of windows and the removal of earth from the building. The Committee has recommended the County withdraw from Civil Defence, despite threats of legal action and surcharges.

The controlling group of Mid Glamorgan County Council have therefore conceded the major points of CND's demands, though these recommendations together with Officer's reports, will be the subject of a Full Council Meeting, probably on March 18th.

#### WHAT A WEEK!

Taken with the vote in Clwyd, the Peace Movement in Wales has scored enormous successes in the past few days. Mid Glamorgan's preition is critical and potentially the most progressive in Wales, after a long period of inertia and "doubletnink".

Admitting a "change of mind" Cllr Philpin said this was not due to "outside forces" but "careful talks within the group". The Labour Leader indicated otherwise complaining (if we heard him correctly) of "Bunker-itis" i.e. the strength of our peace picket and lobbies combined with inner-party discontent and showers of letters, telegrams etc from all over Mid Glamorgan and wales.

#### WE MUST REMAIN VIGILANT! - and ensure PRACTICE FOLLOWS PRINCIPLE:

- A massive turn out for the Full Council Westing, probably much 18th Please raise this with your group and all possible sources of support including community groups, ward parties, trade unions, miners lodges etc
- The Peace Camp should continue if possible this depends on people or groups offering to do a stint, a few hours or overnight. Please contact Steve Samuel (Tel Pontycymmer 870582) to arrange a time. If staying overnight we can provide food but please bring sleeping bag milk and bread (these are difficult items to obtain on site)
- Keep up the pressure on <u>Elected Members</u>. There must no retreat due to surcharge threats. The arms bill is an enormous surcharge on us all Perhaps CND could consider launching a "Defence and Aid Fund" thus taking a practical step to resist the Governments discredited policies.
- We must now widen the Campaign Mid Glamorgan should tell the Home Office we want their bunker out of the County. We shall deliver a massive "Notice to Quit" from All Wales on April 10th!

## CND's reply to the Statement of Intent laid before the Public Protection Committee

- 1. CND entirely supports the intention to withdraw from the Government War Emergency Scheme though we do not under estimate the difficulties of doing so. Obstacles will undoubtedly be placed in the Council's path. They are no alone in taking such actions or in surmounting obstacles. A powerful peoples movement now supports the 170 or so Nuclear Free Councils. many Councils have successfully some further in resisting the Governments discredited 'Home Defence' plans, including Lothian, Greater London, South Yorkshire, Birmingham, etc We are not aware of any Councillor being surcharged due to his authority's non compliance with 'Home Defence' planning. Councils in wales are now in a strong position to take such action since every Council now supports nuclear free policies. Unity is strength. We call upon mid Glamor an not to retreat but rather, as the largest Council with a strong and radical tradition for Peace within the County, to provide leadership and unite with other councils to resist
- 2. CND supports the view that officers should interpret their duties in a manner consistent with the belief that there is no meaningful defence to nuclear war

Government proposanda films which fuel the arms race should not be

shown in County schools or premises.


At present officers face a possible conflict of loyalties between their duty to the Council and its ratepayers and that to Government policies via the Home Office who arrange training and provide grant aid. The Labour Party recommends only minimal compliance with the latter such as collecting and publishing information.

CNDs view is that officers should be encouraged to undertake a more positive public role in providing full, frank and accurate information on the dangers of nuclear war and should have powers to exercise

officers should on no account be involved in Government and military exercises such as 'Operation Hard Rock' or on other nuclear war preparations. These create false illusions and detract manpower and other resources from peacetime emergencies.

stringent control over the manufacture. siting and movement of nuclear materials in and through the County area, such as is the

- 3. CND supports comprehensive and effective measures for dealing with neacetime emergencies and notes with concern that the Annual Budget proposes reduced manning levels for retained firemen and reduced highway maintenance together amounting to cuts of £108,000 CND repeats that there was never any requirement on the Council to build the Bridgend bunker at a cost of £389,000 plus fixtures and fittings. Had the Council taken our advice this money would have been raised and spent on providing essential services like those outlined.
- 4. Finally CND believes and stated to the Public Pfotection Committee that this matter has raised important issues about the democratic process in mid Glamorgan County Council especially the role and balance of power between certain officers, Council leaders and elected members. The questions we have asked remain unanswered. What is at stake is the confidence of a large number of the public in democratic decision-making at County Hall. The first casualty of peace is usually democracy that is the real challenge to be faced by the Public Protection Committee if it is to live up to its name.



On 26 February, by 39votes to 1. Councillors recommended the bunker should be modified for peaceful uses only.

CND was told earth would be removed and windows made; no war eqipment would be installed.

The Council are now building windowless concrete walls. 40mm thick. We have no doubt once this concrete sets - within days - this building will be a bunker as planned.

The Clerk says the work cannot be stopped. The Clerk is the Wartime Controller, with a place in the bunker - what is he, the Home Office and the Council Leader playing at??

QUITE SIMPLY - ARE WE BEING DUFED? we. the public, are paying the bills - we demand the work is halted.

## NO EXCUSES - ACTION NOW!

We have told Cty Cllr Philip Squire CND may step up its direct action unless the work is immediately stopped or modified as promised. WE MUST NOW ACT to ensure the Council keeps that promise - Please be ready to respond

#### VICTORIOUS PEACE CAMP LEAVES DUNKER SITE - CAMPAIGN GOES ON

Mid Glamorgan Peace Camp will end at 3.0pm on Sunday, march 21.

There will be short speach by Sty Clir Paul Flynn, who has recently returned from Strasbourg, on behalf of WaNa. Daffodils - the symbol of the anti nuclear movement in wales-will then be planted on the site. We hope these will flower as an affirmation of life and a permanent reminder of our struggle for peace in Mid Glamorgan. Simultaneously many of our supporters will be representing the Peace Camp at the Festival of Life at the sates of Greennam Common.

#### Achievments

When we occupied this site on 24 January, after terrible snows, we set ourselves 4 objectives (see Newsletter No. 1, Jan 31st). These were - to get the war work stopped, to expose the realities of civil defence plans, to further the Councils Nuclear Free Zone policy and to try to build a stronger peace movement. It is no exaggeration to claim that we have acheived each of these goals. We know that we could not have done so without the encouragement, practical support and sacrifice of many people in mid Glamorgan and elsewhere.

approx. 600 people have taken part in the peace picket on site. Meny thousands of others have been active through the nuclear free zone campaigns, distributing leaflets, attending meetings, lobbying, etc and through their peace activities and peace camps giving strength and encouragement to us. The declaration of a Nuclear Free wates and the many visitors and delegations to our peace camp have testified to this strength.

To all of these people and groups, too numerous to mention, we send wishes of peace and love and say a heartfel. Thank You.

#### Peace and Democracy stregthened in Mid Glra

We congratulate our Council on having the course to shange the policy and stand up to War Planners, especially in a week when the arms race has been stepped up by the Governments criminal decision to spend £7,500,000,000 on the Trident submarine missile, in audition to Cruise missiles at Greenham and molesworth. We shall campaign against Trident and Cruise as no campaigned against the bunkers
