Alfred George James (1853 - 1922)

He was a master cabinet maker, who also had a business making coffins. He became involved in a lawsuit over a right of way; which he lost. This loss was very expensive and so he began teaching woodwork in the Grammar School. He kept a shop selling china and furniture on the High Street.

He was a patriotic Welshman - when a series of plates were sent to him to sell on the occasion of Queen Victoria's Jubilee, he noticed that they had motifs for England, Scotland and Ireland but none for Wales - so he had them sent back and some leeks inserted in the design.

Alfred George James visited Russia to stay with his sister on several occasions. He had various adventures doing this - at one time being mistaken for King George, whom he strongly resembled; on another being taken for a spy because of his fondness for sketching. He talked of the time when he was in the Caucasus and had terrible toothache and was very far from any dentist - the local blacksmith took out the tooth 'and it was the least painful extraction I ever had!'

He knew a great deal about the history of Cowbridge. He also wrote about his experiences in the Volunteers in the 1860's.

His obituary (in the Glamorgan Gazette?) reads as follows

The social life of Cowbridge has been robbed of a familiar figure by the death of Mr Alfred G James of Manchester House. Mr James., was a native of the town, and had spent the whole of his life in the old Borough which he loved so well. He was the last surviving sergeant of the old 18th Glamorgan Rifle Volunteers, and many were the entertaining stories he could tell of the old Volunteer days.
