by the last Will and Testament of my dear and sister Elizabeth Kemys  
to have and to hold the said third part of the said messuage and all other  
the premises with the appurtenances unto my said sister Phill Kemys the younger  
her heirs assigns for ever to her & their own proper use and  
benefit for ever & to no other use intent or purpose whatsoever

Item I give & bequeath unto my two Nephews Rowland Thomas and  
Thomas Thomas sons of David Thomas of Clowston the by joint  
of ffive pounds sterling to be equally paid & divided between them  
the said Rowland & Thomas in some convenient time after my
