## Administration Bond: Richard Kemeys: 14th October, 1689

In the Consistory Court of Llandaff, 14<sup>th</sup> October, 1689, administration of the goods etc, of Richard Kemeys, gentleman, deceased, was granted to his widow, Mary Kemeys. Mary Kemeys, William Jenkins of the town of Cowbridge, gentleman, and George Kemeys of the parish of Llanblethian, gentleman, were bound by the Court in the sum of £200 for Mary Kemeys to make and exhibit a true inventory of the goods etc. of here late husband at or before the 15<sup>th</sup> January next, to administer according to law, to give a true account of her administration by the 15<sup>th</sup> September next, and to present to the Court any last will and testament of the deceased that might appear. Mary Kemeys, William Jenkins and George Kemeys signed the administration bond.
