Frustrated trustees to sell Institute

The crumbling Institute building in Cowbridge is to be put up for sale after a public meeting failed to find any alternative.

Only 33 people attended the public meeting to decide the future of the Institute three of them trustees.

The chairman of the meeting, Mr. David Jones, said: "We discussed the situation as it stands and then put the

options to the vote. "Twelve people voted in favour of disposing of the building and appointing a

solicitor. "Four people said we should go out on to the streets of Cowbridge and try to raise the necessary money over the next few months. Some people did not vote at all

With the cut-down in the Town Clerk's hours, Cowbridge council is considering installing an answering machine at a cost of £99

The trustees have looked at every option open to them since the building fell into such disrepair that it had to be closed down

But as they have been applying unsuccessfully for grants they have found their main tenants find other premises.

The scouts and cubs have just had a substantial grant approved for a new building. so it is unlikely they will ever come back to the Institute And Aberthin have just

finished their village hall Mr Jones said there has been a poor response in Cowbridge. Last year the trustees wrote to over 20 local charities and only six

bothered to reply. The local authority were interested in the Institute as a day centre for the elderly but they would not pay for the building to be put in order and we have not got the monev to do it."
