### **Church Street – Deeds and References**

The South Gate is grade II\* listed. The Church is grade I listed; its gate, piers and churchyard walls are grade II listed. The Grammar School is grade II\* listed; the boot house is grade II listed. The wall on the west, to the former Grammar School garden, is grade II listed. Nos 6 and 7 Church Street are grade II listed. CADW/RCAHM

In the early 19th century, there were at least 9 houses on the west side of the street (where two remain today). The first five were demolished in the 20th century to make the Duke car park; two opposite the Grammar School were incorporated into the school in the 19th century, and demolished later in that century to make the lawns, 'covered playground' and 'woodwork shed'. The parish pound was also on this side, tucked in next to the South Gate.

There was also a short street of houses running at right angles to the road, immediately next to the church gate.

'By the church stands, or rather 'stood', for it has now been improved out of existence, a row of old houses, three or four, leading down a side alley by the churchyard wall. The alley was known as Ready Money Lane, but better still as Johnny the Backers. The house with the gable towards Church Street was richer for holding a small image.'

'John Lewis lived in the first house of the row by the churchyard gate. Some of the other houses were empty and dilapidated, and the resort of the town dogs. John Lewis by trade was a shoemaker, but frequently acted as post boy for the Bear.'

- 1947 Nos. 6 and 7 were recorded by the Royal Commission AHM as 'a two unit house of mid 16<sup>th</sup> century date, now divided into two cottages', each of two storeys, two window bays, stone rubble walls, slate roofs. The large central doorways of dressed stone with arched heads original, mullioned casement windows being replacements. Internal details include dressed stone arched doorway, good main beams and hooded fireplace on the first floor. They are Grade II listed. They were formerly nos. 7 and 8 (included as such when surveyed in 1959 and 1962)


