Will of Thomas Phillip of Bwlch Gwin, 6th December, 1702

In the name of god Amen the sixth day of December in the first yeare of the Raigne of our Sovereign Lady Queen Anne Annoqe Dom[ini] 1702 I Thomas Phillip of Bwlch Gwin in the parish of Ystradowen in the Countie of Glamorgan and Diocess of Landaffe being sick and weak in body but od sound and perfect memory (praise be given to God for the same) And knowing the uncertainty of this life on earth, and being desirous to settle things in order, doe make this my last will and testament in manner and forme following, that is to say, first and principally I Commend my soul to almighty god my Creator, Assuredly believing that I shall receive full pardon and free remission of all my sins and be saved by the precious death and merits of my Blessed saviour and redeemer Christ Jesus and my body to the earth from whence it taken to be Buried in such Decent and Christian manner As my Executors hereafter named shall be thoughe meet and convenient And as touching such worldly estate as

the lord in his mercy hath lent me my will and meaning is the same shall be impoyed and bestowed as hereafter by this my will is Expressed

And firstly I doe Revoke renounce frustrate And make void all wills by me formerly made and doe declare and apoint this my last will and testament,

Item I give and bequeath unto my sonne William Thomas my wheeles and Butt my plough and harrows yokes bows and Chaines and all the implements belonging to the oxen

Item I bequeath to William Thomas my said sonne my best brasse brewing pan and my best brass pot

Item I bequeath unto my daughter Elizabeth five pounds to be paid her within three months After my decease

Item I give and bequeath to my daughter Margarett tenn pounds to be paid her within three months After my decease

Item all the rest of my goods Cattle and Chatles whatsoever I give Betweene my welbeloved wife Jane John And my aforesaid Sonne William Thomas to be Equally Divided betwixt them If my said wife remaines A widow or during her widowhood and noe longer

And I doe hereby ordaine nominate and Apoint my said wife Jane and my Aforesaid Sonne William Thomas Joynt Executors of this my Last will and testament In Wittness whereof I have hereunto Sett my hand and seale the Day and yeare Above written
