Will of David Griffith, 28th May, 1719

In the name of God amen the 28th day of May 1719 I David Griffith of the p[ar]ish of Colwinstone in the County of Glamorgan Sadler: being of perfect memory and Remembrance, praised be God, do make and ordain this my last will and testament in manner and forme followeing (viz.)

Imp[rimi]s ffirst I bequeath my soul into the hands of the almigty God my maker hopeing to Receive free pardon and forgiveness of all my sins; and my body to be buried in Christian buriall at the discretion of my executors hereafter nominated.

it[e]m I give to my beloved wife Leucras John the sume of six pounds of current Brittish money and one dust bed one featherd bolster and one small feather cushion with its cover a pair of blanketts and a sad coulered coverled one brass pot and one Bedstead

it[e]m I give to my daughter mary the sume of five pounds of current Brittish money and in amends for the sheep I sold for and a guinea she had from her Grandmother I give her my speckled cow.

it[e]m I give to my sonne Lewis one heifer goeing on too year old:

it[e]m I give to my sonne Griffith one dust bead bead stead a pair of Blanketts and a Red coverled a grey close Coate.

it[em] I give to my sonne Morgan the sume of six pence.

it[e]m I give to my sonnes Thomas and Lewis all the rest of my goods cattles and chattles moveable and unmoveable within and without that they and every and either (upon condition) shall pay my debts Legacies and funeral expences, and make them sole executors of this my last will and testament Revokeing and Adnulling all other wills and testament

This is my last will and Testament of me Ann Thomas of Tymaen in the parish of Colwinston in the County of Glamorgan widow. I give and bequeath the Leasehold property which I hold under Thomas Edwards Esquire of Cowbridge situate in the parish of Colwinston aforesaid to my niece Mary David and her heirs for the term unexpired, I give and bequeath the arrears that Thomas David the husband of the aforesaid Mary David ows me towards the repair of the said Cottage and appurtenances to the aforesaid Mary David,

I give and bequeath the sum of Fifty pounds which I lent to John Thomas of Corntown in the parish of Ewenny by a note of hand which was my son in law to Catherine and Ann Thomas my Grandchildren in equal shares,

I give all the remainder of my personal residuary estate to my son William Thomas whatsoever and wheresoever whom I appoint sole executor of this my last will and Testament revoking all former wills by me made heretofore. I ordain this and no other to be my last will and Testament. In Witness wherof I have directed my name to be signed and seal final in the presence of these who have subscribed their names, as witness in her presence and in the presence of each other having fully explained to her when she appeared to understand the same.
