BURGAGE ROLLS from 1738 to 1816

SUMMARY

Nos 23 – 31 High Street, Cowbridge

No 23- Taynton House has been in the ownership of the Taynton family from at least 1738 and members of the family were occupying the property until 1816. The property consisted of 1 burgage. The 1841 Tithe assessment shows no 23 as one property owned and occupied by Francic Stanton (Taynton?) in hand house & garden.

No 23 – Taynton House. Western side. This property consisted of 3/4burgage and adjoined no 23. It was owned by Pierce Cornish from at least 1738 until between 1779/80. In 1783 it was shown in the ownership of the Rev. Francis Taynton and remained in the ownership of the Tayntons until 1804. Between 1738 and 1778 it was occupied by Alexander Williams and his wife. Alexander was a tailor. He died in or before 1767 and his wife Mary was the named occupant.

By 1783 until 1816 David Jones was the occupier and it was known as The Black Horse.

No 25 – John Carne owned the premises in 1738: followed by Walter Coffin around 1779/80 and between 1805 and 1816 James Markham. The first occupier was Jenkin Jenkins in 1738 and then Wenllian Jenkins and John Lewis. In 1780 the property was vacant and known as the 3 Boars Head. Between 1783 and 1787 it was occupied by Thomas David, Mr Coffin and Jane How, and between 1798- 1804 by Jane How and Morgan David and known as The Boars Head. The occupant between 1805- 1816 was Thomas Jones of The Boars Head. In the 1841 Tithe assessment the owner was John Nicholl Carne and Thomas Thomas the occupant and it was a public house Three Boasrs' Head.

No 27 – in 1738 William Davies was shown as the owner and after 1767 the property was was owned first by Mrs Edmondes and then passed to Thomas Edmundes . The tenants were Catherine Thomas a widow in 1738 and in 1767 it passed from Catherine to William Evans who remained there until 1779/80 when Thomas Lougher was tenant. From 1783 it was known as the Red Lion and the tenants between 1783 and 1787 were Richard Jones and Robert Thomas. Robert Thomas remained until 1804 and ? Thomas was tenant between 1805 and 1816. In 1841 Tithe assessment owned by Thomas Edmundes and occupied by David Lloyd – White Lion public house.

No 29 – In 1738 David John was owner/landlord and Thomas Morgan the occupant. By 1767 the property passed from David John to Edward Thomas and the occupancy from Margaret Morgan, widow to George John and then William Thomas. In 1772 it was

shown as belonging to William Davis and then Mr Edmondes and occupied by Cath. Thomas, wid and William Thomas. In 1774 it had changed again with David John owner and Mary Morgan wid. In 1780 it was still Edward Thomas as owner and John Thomas tenant and now known as The Crown, which it remained until at least 1816. It was owned by Mr Carne and Jenkin Jones was tenant in 1783. In 1805 it was in the hands of Thomas Markham and the occupant James Hiscock. 1841 Tithe assessment owned by? Carne and occupied by John Gibbon – house and garden.

No 31 – From 1738 Sampson Sweeting was owner and the property was a Tanyard. It remained in the ownership of Sampson Sweeting until at least 1774, although between 1767 and 1772 it was also shown as Mr Jones. Mr Jones was the owner/landlord until between 1805 – 1816 when it was Thomas Hunt. It would appear that there was no occupant in 1738 but by 1767 there was a Thomas Thomas a glazier followed by John Lewis. It ceased rto be termed a Tanyard between 1778 and 1783. In 1783 Mr B Thomas was was tenant followed by Mr Brown and Mrs H Thomas. Mrs H Thomas remained until 1798 –1804 . Robert Thomas and Robert Jones and Thomas Hunt between 1805 – 1816. From the Tithe assessment of 1841 owned by Thomas Howell, in hand – house and garden.
