1597 Robert Thomas of Michaelston juxta Cowbridge to Ann Thomas, his dau, wife of William Thomas
Grant of the reversion and remainder in fee simple to take effect in default of issue male to Wm Thomas, the grantor's son, and Elenor his wife.... The manor of Michaelston, Knelston and Burry, a mess and lands in Llandow, and a messuage curtilage and garden in the town of Cowbridge

1608 Sale by Richard Budd and Richard Gwynne of London to Sir John Carne of Ewenny, of land called Priors Hill and wood and meadows between the R Thaw and Cowbridge

Penrice & Margam 4c, 2810

1523 Lease by the Commons of the town of Cowbridge to William Prenche, burgess, of Priour is hill, with wood and meadow adj to the Thaw on the west, town lands on E, Halfpenny mede and Halfpenny lake on N, and land of William Bassett, gent, now held by Rees Mawncell on S, for 70 years
(subsequent deal: Priors hill alias The Lake)

1889 Lease for 60 yrs of coal under Gellyfanches, Llanwonno, Revd Thomas Edmondes to Herbert Kirkhouse of Brynbedw, Tylorstown, colliery proprietor, and Sir Williaqm Thomas Lewis of the Mardy, Aberdare

Cilybebyll 263

1769 Lease, John Edmondes and Charlotte his wife to Mrs Mary Carne
Of house where she now lives, outhouse used as a dairy by Thomas Lewis, gent, the Late tenant and occupier of said house, for 2 lives, adjacent to the house where John Edmondes now lives

Aberthin

- 1831 David John and William John of Cowbridge, carriers; mortgage to Jas Kidman of Cardiff, gent
Recites
- 1823 Revd E Morgan devised to Dd John all that piece of ground at the Limes where Dd and Wm John
have lately erected a dwelling house occupied Mary Vincent (99yr lease)
- 1825 Corpn of Cowbridge devised to Dd John all that mes formerly held by Margaret Preece, ww, and
now occ D and W John, for 99 yrs or 3 lives (Ann John then 20, Dd John 18, Simeon John, 12)
- 1828 Isaiah Verity demised to Dd John stable, garden ans premises since converted into a warehouse,
garden, stable and premises in East Village, occ D and W John (99 year lease)
endorsed surrendered
