Dear Lewis:

I was very disturbed after talking to you on the telephone on Sunday evening and more disturbed when I received your letter yesterday.

I do not believe that we had agreed on anyone being officially asked to serve on the committee. Mrs. Monkhouse and Rev. Jones were mentioned as possibilities for "a" committee. Nothing was said or decided about asking Mrs. Monkhouse to be Treasurer.

I think the meeting on October 1st should be just the two of us with Mark Gattley (and other hotel personnel) and after completing that portion of the business then the two of us should then discuss our officers and committee chairpersons.

I have approached a few possible candidates for the different committees and I am sure that after we have had our meeting we will have made some good choices.

I am not sending a copy of this letter to Mrs. Monkhouse or Rev. Jones for two reasons--I think you should talk to them personally and I do not have their addresses.

Thank you for your letter of September 22 which unfortunately did not arrive until this morning.

It would appear that our recollection of our meeting and of our telephone conversation differ considerably, and this is most regrettable. It is my clear understanding that Mrs. Monkhouse and Rev. Jones were confirmed by you as Committee members during our meeting, and my suggestion that they be asked to attend the October 1st meeting as made during our telephone conversation was not objected to by you. My letter, through which both were invited, was sent in good faith, and as it is probable that both Rev. Jones and Mrs. Monkhouse have made arrangements to attend I do not feel that they should be told not to come at this late date.

I agree with you when you say that nothing was decided about asking Mrs. Monkhouse to be Treasurer, although it was discussed, strictly as a possibility.

I am sure that we can arrange matters on Saturday to accommodate different viewpoints about attendance at the meeting. It will be to our advantage to have two members of the Board of Trustees in Niagara Falls, especially as the Board itself suggested strongly that we use Board personnel as Committee members.


We now have a report for you regarding our first meeting for the 1979 Gymanfa Ganu. We wanted to be able to tell you the names of the Chairmen of the different committees.
